What is a Quick Assist Loan (QAL)?

- A program established to prevent Sailors and Marines from falling victim to predatory lenders
- An interest free loan, up to **\$300**, for qualified **Active Duty Navy and Marine Corps** service members provided in as little as 15 minutes. **Limit two (2)** within a 12 month period as long as the first loan is paid off.
- Available from **all** Navy-Marine Corps Relief Society offices
- **For what types of needs can a QAL be used?**
- Basic Living Expenses
- Medical / Dental
- Vehicle / Transportation
- Family Emergencies

How can you apply?

- Bring **Active Duty ID Card** and **most recent LES** with you to your local NMCRS office. **No appointment necessary.**
- Fill out a short, one page application. Applications available in the offices or on the web at www.nmcrs.org
